Housing Technical Report

Provides a wealth of information and resources that clearly articulate:

- the housing need in the region (RHNA),
- the challenges with housing production (costs, lack of funding, jurisdictional processes, CEQA, community opposition, and others), and
- a series of tangible and responsive best practices that jurisdictions can pursue to advance housing production in the region
 - funding from state and federal agencies
 - technical assistance
 - streamlining the approval process
 - community education
 - housing-supportive infrastructure investments, among others

Regional Planning Policies (Approved by Board in July)

- Housing-specific regional planning policies provide a clear means to reflect alignment with the plan to:
- support local access to grant funding
- resource for lead agencies to reference when determining consistency
- The Regional Planning Policies emphasize:
- Encouraging housing development in areas with access to important community resources
- Encouraging housing in transit supportive and walkable places
- Supporting affordable housing preservation while addressing additional housing needs across region
- Supporting community stabilization
- Promoting innovative homeownership strategies
- Supporting programs that reduce housing cost-burden
- And, programs that support housing and service for people experiencing homelessness

Implementation Strategies

- Implementation Strategies—Specific actions SCAG will take to advance studies and plans that help us achieve the Regional Strategic Investments, as well as, advance Regional Planning Policies.
 - **Technical Assistance** for jurisdictions to complete and implement their housing elements and support local governments and Tribal Entities to advance housing production
 - **Partnerships** to align utility, transit, and infrastructure investments with housing development and equitable outcomes across the region.
 - Identify innovative homeownership models
 - Develop and deploy community stabilization (anti-displacement) resources

Regional Strategic Investments

- Draft plan assumes \$3 billion generated from Value Capture
 Strategies to fund infrastructure to facilitate housing production
- Connects need for housing funding with our ability to achieve mobility and climate goals
- Need for housing funding demonstrated by success/oversubscription of REAP 1, 2 programs
- Re-enforces and prioritizes securing a dedicated funding stream for housing as an essential policy goal for the region and focus on SCAG's programs

RHNA Reform – Legislative Concepts

- 1. Extend Existing Need
- 2. Ensure a Transparent Process
- 3. Establish Panel of Experts

Concept 1: Extend Existing Need

- Extend existing need from the regional determination across multiple planning cycles.
- Correspondingly, extend the Housing Element planning periods over multiple cycles to be consistent with the extension of the determination period for existing need.









Concept 2: Ensure a Transparent Process

- Establish procedures for HCD to publicize its data sources, analyses, and methodology prior to finalizing the regional determination.
 - Including assumptions and factors used in the Department of Finance's projections and HCD's engagement processes with the Councils of Governments.



Concept 3: Establish Panel of Experts

 Require HCD to convene a panel of experts that would advise the department on its assumptions, data, and analyses prior to HCD making its final determinations.




Concept 4: Increase Due Process Opportunities

• Establish additional due process opportunities for COGs and jurisdictions to appeal the methodology and assumptions used for housing need determination.




Concept 5: Advance the Regional Determination

 Require that HCD provide the regional determination to a COG earlier than the current 26-month time frame.



Concept 6: Reinstate Trade & Transfer

- Reinstate a trade and transfer option of RHNA units between two jurisdictions.
 - Include limitations or guardrails so Trade and Transfer also furthers state housing objectives, including affirmatively furthering fair housing.

QUESTION 1

• How can we further AFFH if we reinstate trade and transfer?

- Examples:
 - Only disadvantaged communities can initiate trade and transfer.
 - Trade and transfer is only limited to market rate housing.
 - Resources generated from trade and transfer can only be used to produce affordable housing.

Question 2

 What types of parameters are needed to ensure the determination process is transparent?

• Example:

- All data sources, analysis, and other information used by HCD are posted prior to the regional determination.
- Require public access to meetings participation vs listening.

QUESTION 3

Who should be on the third-party panel of experts?

- Example:
 - U.S. Census
 - Members of Academia
 - Demographic staff from another COG
 - Another state's Department of Finance






